

# Pho Trading Ltd – “Win a Free Trip to Vietnam” Competition

## Terms & Conditions

### 1. Promoter

The promoter of this competition is **Pho Trading Ltd** (“Pho”).

### 2. Eligibility

- The competition is open to residents of the United Kingdom aged **18 years or over** at the time of entry.
- Employees of Pho Trading Ltd, its agents, affiliates, or immediate family members are not eligible to enter.
- Entry is subject to these Terms & Conditions.

### 3. How to Enter

- To enter, customers must **dine in at any participating Pho restaurant on Tuesday, 17 February 2026**, the first day of Vietnamese New Year (Tết).
- Customer must purchase one main meal to participate.

### 4. Competition Period

- The competition is valid **only on 17 February 2026** during participating restaurant opening hours.
- Entries received outside this date will not be valid.

### 5. Prize

- One (1) winner will receive a **free trip to Vietnam** for two (2) people, which includes:
  - Two (2) economy class round-trip flights from a major UK airport to Vietnam (Hanoi or Ho Chi Minh)
  - Five (5) consecutive nights' accommodation in a hotel selected by Pho or its travel partner
- The prize does **not** include spending money, travel insurance, visas, vaccinations, meals (unless stated), airport transfers, or any other expenses not expressly listed.

### 6. Winner Selection & Notification

- One customer will be selected **at random on the day** and presented with a **lucky red envelope** containing the prize.
- The decision is final and no correspondence will be entered into.

### 7. Prize Redemption & Travel Dates

- The prize may be redeemed for travel between **1 March 2026 and 28 February 2027**, subject to availability.
- Travel is **not valid** during:
  - UK bank holidays
  - UK public holidays
  - UK half-term school holiday dates
- Exact travel dates must be confirmed in advance and are subject to flight and accommodation availability.

### 8. Conditions of Travel

- The winner and their companion must travel together on the same itinerary.
- Valid passports, visas, and any required travel documentation are the responsibility of the winner and their guest.

- Pho Trading Ltd is not responsible for any costs incurred due to failure to obtain appropriate documentation.
